

# Senior Services

*A Guide to Senior Citizen Information*

*Using revenue from the state Lottery Fund, Pennsylvania offers senior citizens a variety of programs and services to help them save money, stay healthy and maintain mobility.*

## Property Tax/Rent Rebate Program

This program offers qualified state residents refunds of up to \$650 on property taxes or rent.

**The program is open to:**

- state residents age 65 or older;
- widows and widowers age 50 or older;
- permanently disabled state residents age 18 or older;
- homeowners whose total annual income from all sources – counting only half of their Social Security or railroad pension – is under \$35,000.
- renters whose total annual income from all sources – counting only half of their Social Security or railroad pension – is under \$15,000.

## PACE and PACENET Prescription Programs

**PACE** cardholders are able to purchase generic prescription drugs for \$6 and name-brand drugs for \$9 at local drug stores.

**The program is open to:**

- state residents age 65 and older
- with an annual income under \$14,500 for single persons or \$17,700 for married couples.

**PACENET** is a prescription assistance program for people with slightly higher incomes. Cardholders must meet a set monthly premium, after which they pay \$8 for generic medications and \$15 for name-brand prescriptions. If the premium is not met each month, it will accumulate.

**The program is open to:**

- state residents age 65 and older
- who have an annual income up to \$23,500 for single persons, and \$31,500 for married couples.

## Healthy Horizons Medicare Savings Program

Healthy Horizons is a special medical assistance program from the Pennsylvania Department of Public Welfare. This program is designed to ensure adequate health of the elderly and disabled persons with low incomes. It may also allow seniors to keep more income by paying their Medicare premiums.

## Reduced-Fee Camping at State Parks

State residents age 62 or older are eligible for a \$4.50 reduction in camping fees at all state parks.

## Hunting and Fishing License Savings

State residents age 65 and older are eligible for reduced rates on hunting and fishing licenses.

- Senior hunting license – \$13.70
- Lifetime hunting license – \$51.70
- Senior fishing license – \$11.70
- Lifetime fishing license – \$51.70

Free fishing licenses are available to Pennsylvania veterans with 100 percent service-connected disabilities.

## Reduced Rates for Dental Care

The Senior Dental Care program, offered by the Pennsylvania Dental Association, provides eligible senior citizens with discounts of at least 15 percent on dentist visits.

### The program is open to:

- individuals age 65 and older
- who have an annual income under \$14,500 for single persons or \$17,700 for married couples and
- who have no federal, state or private dental health assistance or insurance.

## Motor Vehicle Registration Discounts

Retired state residents whose total annual income from all sources does not exceed \$19,200 are eligible to register their motor vehicles with the state for only \$10.

Pennsylvania Department of Transportation form MV-371 must be submitted with each renewal.

## Transportation Assistance

State residents age 65 and older qualify for transportation assistance from the state under the Shared-Ride and Free Transit programs.

- Shared-Ride provides senior citizens with reduced-fee, door-to-door transportation.
- The Free Transit program allows senior citizens to ride free on local public transportation (buses, trolleys and rapid-transit lines) during off-peak hours, weekends, and certain holidays. Participants must obtain identification cards, which are available free of charge from participating transportation providers.

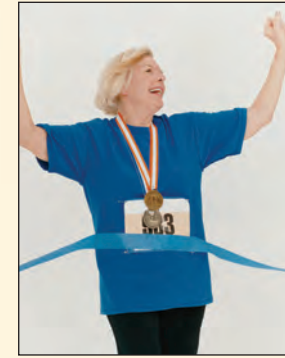
Applicants for either program must be prepared to provide proof of age.

## State Income Tax Exemption

Retired state residents are not required to pay state income taxes on Social Security payments, railroad retirement, any pension benefits (including veterans' benefits), or Supplemental Security Income.

## Discounts at State Museums and Historical Sites

State residents age 60 or older may be eligible for reduced-admission prices at properties and museums operated by the Pennsylvania State Historical and Museum Commission.
